



## PRIVACY POLICY

Thank you for visiting our website. Your privacy is of utmost importance to us. This Privacy Policy outlines the types of information Free Tribe Network (“Free Tribe Network”, “we”, or “us”) collects from and about you, as well as from others, when you visit our website (the “Site”). It also explains how we may use and disclose such information and your options for controlling certain uses of it. By using this Site, you consent to the data collection, use, disclosure, and storage practices described in this Privacy Policy.

### INFORMATION COLLECTION METHODS

We may collect various types of information from or about you and your devices when you interact with the Site, as detailed below.

#### Information You Provide

We collect information you voluntarily provide, such as when you fill out forms on this Site. This includes requests for information, newsletter sign-ups, event registrations, job applications, donations, or other communications with us. The information collected may include your name, address, email, phone number, geolocation, photos, videos, username, or any other data you choose to submit.

If you log in, link, or communicate with us via a third-party service (e.g., social networks, video chat services), we may receive information about you based on your privacy settings with those third-party services.


Financial information, such as credit/debit card numbers, provided for transactions will be processed by third-party vendors like Flutterwave. Free Tribe Network does not store or handle this financial information.


If you apply for a job or become an employee, we may collect information necessary to process your application, including your name, contact details, and tax identification number.

#### Information Automatically Collected and Cookie Statement

We may use cookies, web beacons, pixel tags, log files, or other technologies to automatically collect certain information when you use the Site or interact with our emails and online advertisements. This information may include your device identifier, MAC address, browser type, operating system, device model, software version, IP address, ISP carrier information, and domain name from which you accessed the Site. Additionally, we may collect information on your usage of the Site, such as visit dates and times, pages viewed, time spent on the Site, return visits, and interaction with emails and ads.

We use services like Google Analytics to gather and analyze this data. These services may also collect information about your usage of other websites and online resources. - Detect, prevent, and respond to fraud and reputational concerns.
- Comply with applicable laws and our Terms of Use.
- Any other purpose described at the point of data collection.


### **INFORMATION SHARING**

We may share your information:

- With your consent.
- With selected third parties that offer donor benefits, promotional materials, or services that may interest you.
- With Service Providers (as defined) for business, professional, or technical support functions, subject to the restrictions in this Privacy Policy.
- With our affiliates or related entities for purposes described in this Privacy Policy.
- If we believe there is a violation of our Terms of Use or the rights of any party.
- To comply with legal processes or provide information to law enforcement or regulatory agencies as required by law.
- As disclosed at the point of collection.
- As permitted by you.

We may also share aggregated or anonymous non-personal information with third parties for marketing or analytics purposes.





In the event of a corporate transaction, such as a merger or acquisition, your information may be transferred to the involved parties. Should such a transaction occur, we will make efforts to ensure the transferee uses personal information in a manner consistent with this Privacy Policy.
